会议背景与主题

当前世界正深处"百年未有之大变局",世界贸易组织(WTO)的多边贸易体制陷入发展的停滞期和瓶颈期。WTO 第 12 届贸易部长级会议将于 6 月 12-15 日在瑞士日内瓦总部召开,是疫情以来的第一次贸易部长会议,也是新任 WTO 总干事以来的第一次部长级会议,是否能够开启新的发展,受到广泛的关注。另一方面,近年来 WTO 多边贸易体制面临挑战,WTO 改革箭在弦上,农业谈判举步维艰,数字贸易等新领域的协定亟需推进。

中国作为全球第一大货物贸易国和第二大经济体,不仅是 WTO 的重要成员,也对国际贸易组织的建设和维护贸易秩序起到重大的作用。中国在 WTO 的多边贸易体制中如何定位,如果推动 WTO 改革的发展,都是重要的研究主题。

基于以上背景,本会议旨在探讨 WTO 改革、农业谈判以及数字 贸易等重要的新议题。重点聚焦以下几个方面:

- (1) WTO 多边贸易自由化与改革前景;
- (2) 多边农业贸易谈判;
- (3) WTO 第12届部长级会议进展与展望;
- (4) 数字贸易发展与规则。

Conference Background and Topics

At present, the world is in the midst of "big changes unseen in a century", and the multilateral trading system of the World Trade Organization (WTO) has fallen into a period of stagnation and bottleneck in development. The 12th trade ministerial meeting of the WTO will be held at the headquarters in Geneva, Switzerland from June 12 to 15. It is the first trade ministerial meeting since the epidemic and the first ministerial meeting since the new WTO director-general. Can it be opened? The new development has received extensive attention. On the other hand, in recent years, the WTO multilateral trading system has faced challenges, WTO reform is on the horizon, agricultural negotiations are struggling, and agreements in new areas such as digital trade are in urgent need of advancement.

As the world's largest trader of goods and the second largest economy, China is not only an important member of the WTO, but also plays an important role in the construction of the international trade organization and the maintenance of the trade order. How China is positioned in the WTO's multilateral trading system, and if it promotes the development of WTO reform, are all important research topics.

Based on the above background, this conference aims to discuss important new issues such as WTO reform, agricultural negotiations and digital trade. Focus on the following aspects:

- (1) WTO multilateral trade liberalization and reform prospects;
- (2) Multilateral agricultural trade negotiations;
- (3) Progress and prospect of the 12th WTO Ministerial Conference;
- (4) Digital trade development and rules.

Dr. Gong Xifeng has solid training in agricultural economics and agribusiness management. He received his Ph.D. major in agricultural economics and management focused on IPR issues analysis for the Chinese agricultural sector from China Agricultural University and obtained his Master of Agribusiness management at the University of Philippines at Los Banos. Professor Wang joined the NPSIA faculty in July 2003 as Assistant Professor of International Affairs. Prior to joining the full-time faculty, she worked at the World Bank as a consultant from 2001 to 2003, and as a researcher in the State Economic & Trade Commission, P.R. China from 1995 to 1997.

Professor Wang's research has been on the empirical issues related to international trade and foreign direct investment at both the macro and micro levels. She studied the effects of imports on productivity in developing countries, and the effects of foreign direct investment on local firms' productivity and survival using firm-level data for both Canada and China. 


